Meeting Called to Order

Approval of Updated Budget Schedule

This change still allows for the approval of the Budget and Appropriations Ordinance on July 20, 2020.

Other Items to be Brought Before the Board

Essential BPD Operations During State of Emergency Discussion

Staff updated the Board on the impact of the Stay at Home Order on Parks Department operations, detailing precautions taken such as social distancing and shift staggering, and sought direction on how best to proceed with maintaining the District and preparing it for the summer. Of three scenarios presented, the Board believed Scenario #2 best balanced safety with maintaining parks and readying the District to meet the demand for services when the Stay at Home Order is lifted.

Oasis Operations Discussion

Pre-season Oasis concerns were shared with the Board. In light of the Governor's Stay at Home Order and the uncertainty of when it will be lifted, the Park District must be cognizant of a number of operational issues – lifeguard training, inventories, manager meetings, etc. – in addition to maintenance and preparation issues. Staff members are continuing ahead with what they can at this point, such as interviewing staff via phone and following guidance from the State, IAPD, and IPRA, but many responsibilities will remain between the time the pool is filled and when it can open to the public.
